# IDEA Funding

### Source of Funds

The Federal Government provides funding for the purpose of providing for the excess costs of special education and related services to children with disabilities ages six through twenty-one. It is a part of the Individuals with Disabilities Education Act (IDEA). The State calculates this funding based upon a Federal three-part formula:

 A base amount of \$323,428,031 determined using the December 1999 California Special Education Management Information System (CASEMIS) pupil count;
85% of the remainder using Prior Year K-12 enrollment (Public and Private school); and

3. 15% of the remainder using Prior Year K-12 poverty (Free and Reduced Meal Counts).

### **Funding Allocation**

The Sacramento County SELPA allocates IDEA, Part B, Section 611 funds using the following categories:

- **IDEA Entitlement**. Funds are allocated by the Member's prior year special education pupil count.
- **IDEA Private School**. Funds are allocated by a proportionate share calculation, if applicable.
- **IDEA CEIS**. Funds are allocated by a percentage factor, if applicable.
