Funds may also be used for preschool related activities for students with disabilities that have an IEP. <i>Program Specialist/Regionalized Services</i> funds are used for such services as defined, in part, <u>here</u>. <i>Low Incidence funds</i> are used for special education and related services to student with low incidence disabilities as defined <u>here</u>. <i>Out-of-Home Care</i> funds can be used in the same manner as AB 602 Base Funds. <u>Out of Home Care Use of Funds</u>

CDE Extraordinary Cost Pool	No	No	Yes	 The Extraordinary Cost Pool for Nonpublic Nonsectarian Schools (NPS) / Licensed Children's Institutions (LCI) is offered by the California Department of Education. This program may reimburse SELPA for extraordinary costs of single placements in nonpublic, nonsectarian schools after 1997–98, and special education and related services for student(s) residing in licensed children's institutions. Costs for mental health, room and board, residential care services, legal expenses, and parent's travel reimbursement are not eligible for reimbursement under the ECP program.
